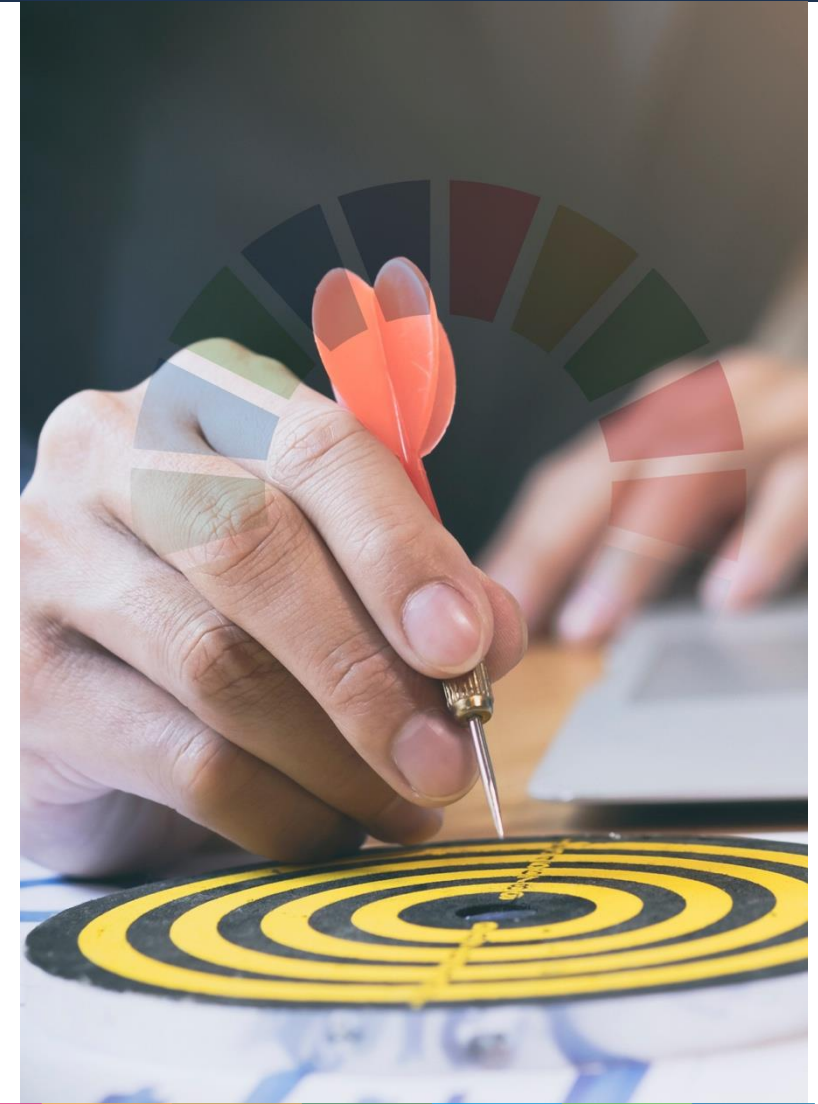


# Why Participate?

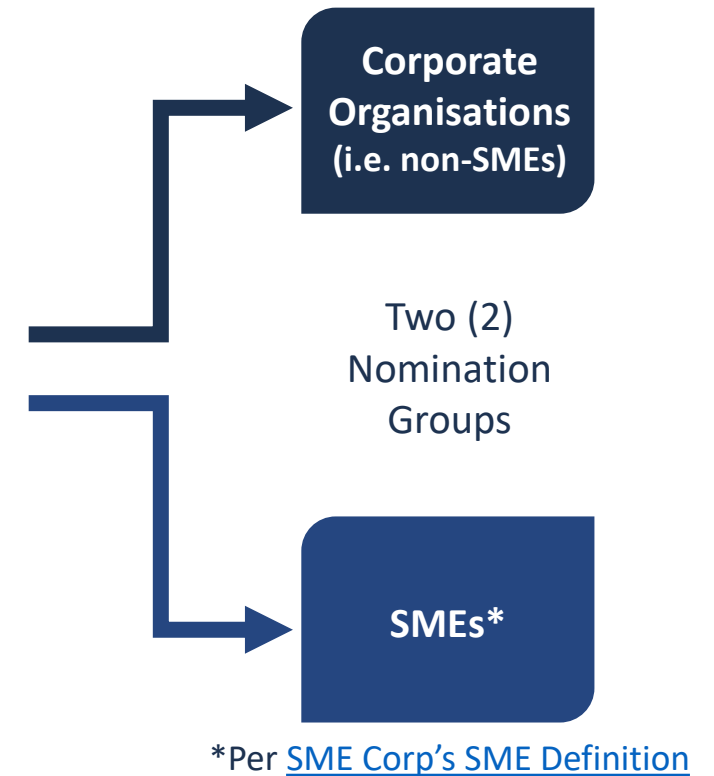

This award is to recognise organisations that have taken a range of actions to address key barriers to women's participation in the labour force and create an inclusive workplace where all employees are respected and empowered.

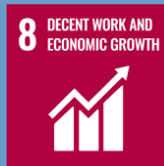

This award is to recognise organisations that have embedded circular economy practices into material selection and product design by ensuring those materials and feedstocks are sustainable to the highest possible environmental and social standards, within the scope of business operations, products and services.

## Science-based emissions reduction in line with a 1.5°C pathway

This award is to recognise organisations that have reduced emissions in line with a 1.5 degree celcius pathway and have validated that their targets are consistent with Science Based Targets initiative (SBTi) criteria.

## SDG Ambition Benchmarks Disclosure Recognition

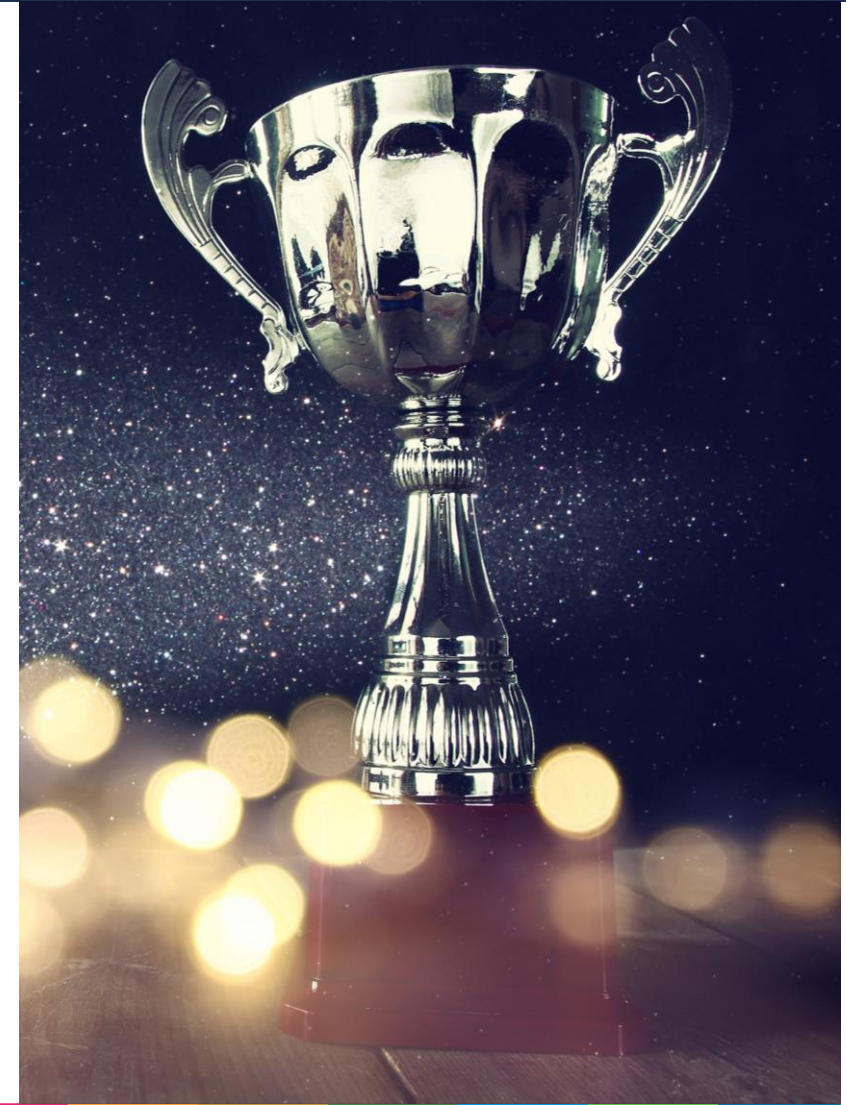
This is to recognize and showcase organisations that has made disclosure of data in reports aligning to the SDG Ambition Benchmarks.

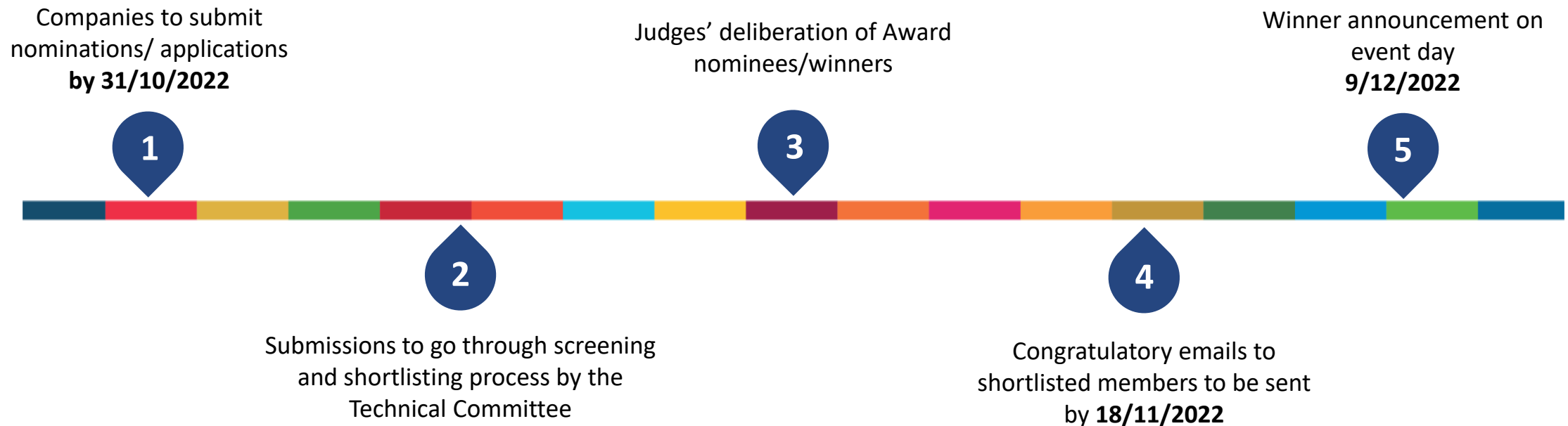
